IPC Wheelchair Dance Sport Championships Competition Fee

Dear NPC President/Secretary General,

With the 2008 IPC Wheelchair Dance Sport World Championships in Minsk, Belarus swiftly approaching, we would like to take this opportunity to inform you about the IPC's policy regarding the payment of entry fees and capitation taxes applied for IPC Wheelchair Dance Sport World Championships. As many of you are aware from past IPC World Championships, NPCs were required to make direct payments to the respective local organising committees (LOCs).

Under the IPC World Championships Competition Fee Management scheme, the IPC will now directly collect these fees, which will provide the organisation with a mechanism to actively direct NPC investments made to ensure quality levels of service and ultimately a successful Championships and sport.

As you will have noticed from the invitation package sent by the LOC, the only other charges levied for the Championships are the costs of accommodation and breakfast. All other services, including arrivals and departures, local transport, meals, etc. are covered through the IPC Competition Fee and LOC financing.

For the 2008 IPC Wheelchair Dance Sport World Championships, the Competition Fee) is **300€ (Euro) per delegation member** (i.e. athletes and NPC team officials and covers the duration of Championships services from 24 October – 27 October 2008.
