1. Invitation

FITAV, Federazione Italiana Tiro a Volo, Lonato 2018 Organizing Committee and World Shooting Para Sport, are pleased to invite you to the "Lonato 2018 World Shooting Para Sport Championships" that will be held in Lonato, Brescia – Italy from 2 to 7 OCT 2018.

The Provisional Events program is attached to this General Information.

Pre-Event Training will take place one day before the competition. Unofficial Training: <u>any day before PET</u>. The Final Competition Schedule (including PET) will be distributed after the Official Entry Deadline (30 days before the Official Arrival day) in accordance with ISSF and World Shooting Para Sport Rules and Regulations. The latest Schedule updates will be provided at the Technical Meeting.

3. Rules and Regulations

The competition will be conducted under ISSF and World Shooting Para Sport Rules and Regulations. Detailed information is available on:

4. Participation

Viability of Events

Individual events are considered viable if there are athletes from a minimum of four (4) countries entered through the Entry by Name.

Team events will be considered viable if a minimum of three (3) eligible NPCs have entered teams through the Entry by Name (note: in case where only 3 teams participate, medals will be awarded according to the minus-one rule).

If an event fails to meet the above minimum viability criteria, the event is not considered viable and will be cancelled.



International Classification

International Classification will be conducted on **3-4 OCT 2018**. A detailed classification schedule will follow after the revision of the final entries by World Shooting Para Sport. At least four (4) weeks prior to classification, the athlete's completed IPC Medical Diagnostics Form (MDF) and Classification Consent Form must have been uploaded to the athlete's SDMS profile, these forms can be found on the World Shooting Sport website: www.paralympic.org/shooting/rules-and-regulations/classification

Results, Rankings and Records

After the competition is finished, results will be reviewed and published on the World Shooting Para Sport website and the Ranking and Records list will be updated accordingly.

Only athletes that are licensed, have a sport start status Review (R) or Confirmed (C) and reach the rankings cut-off standard for the relevant event, will have their results recognized for ranking purposes. For further information see the World Shooting Para Sport Rules and Regulations

5. Entry Process

Athlete Eligibility

All entered athletes in the Lonato 2018 World Shooting Para Sport Championships must be licensed by the final entries deadline. Athletes' entries not meeting this criterion will be rejected by World Shooting Para Sport.

Minimum Qualifying Score (MQS)

In order to be eligible to compete, athletes must have obtained an MQS at a previous WSPS Para Trap competition. The score for each discipline is outlined in the table below:

Authorized Organization for Entry Registration

All athletes must be entered by their respective NPC's or organizations authorized by the NPC and accepted by World Shooting Para Sport

Entry Restrictions

1) Maximum number of athlete entries per NPC event

The maximum entry per NPC is four (4) "full" participants per event (athletes eligible to progress to the final, and to obtain records and ranking).

NPCs may additionally enter an unlimited number of "MQS-only" athletes (athletes are eligible to obtain qualification scores to be recognized for MQS, but cannot progress to the event final or obtain records or rankings).

However, in case of insufficient firing points this number may be restricted by World Shooting Para Sport, in a timely manner.

When entering more than 4 athletes to an event via the Online Entry System, the NPC should contact World Shooting Para Sport after making the online entries, confirming which athletes are to be entered as "full" entry and which as "MQS" only.

2) Maximum number of starts per event

The maximum number of starts per event is the number of the athlete entries that can be accepted per event; this calculation is based upon range capacity and the competition schedule.

If the maximum number of starts is reached during the Final Entry Process: -the number of "MQS only" may be limited to allow space for entry of "full participants"

-a waiting list may be established and, in case of subsequent entry cancellations, entries from the W.L. will be accepted on a first-come-first-served basis

Preliminary Entries (Entry by Number)

IPC Member Federations entering the Lonato 2018 World Shooting Para Sport Championships must submit the Preliminary Entries not later than 2 AUG 2018.

Please use the World Shooting Para Sport Online Registration Service outlined in the SDMS information packet.

Final Entries (Entry by Name)

World Shooting Sport Member Federations must submit their Final Entries directly into SDMS. The Final Entry Deadline is **2 SEP 2018.** All entries must be made using the SDMS system.

Late Entries

Late Entries (submitted after the Final Entry by Name deadline) will only be considered if they are received by World Shooting Para Sport at least one (1) week before the Official Arrival day.

A <u>Late Entry Fee of EUR 50,00</u> will be charged per each additional athlete entered. The amount will be invoiced to NPC by Local Organizing Committee.

Entry Changes

1) <u>Replacement entries</u> may be accepted in the same event only due to injury of medical reason. The NPC must submit a valid medical report to World Shooting Para Sport office for approval.

2) <u>Substitution of an athlete</u> (in a team only) by another athlete already registered in that event can be made <u>not</u> <u>later than</u> 30 minutes before the scheduled start time for that event (ISSF Rule 6.6.5.b). but <u>only</u> if the requested change <u>does not cause any conflict</u> with ISSF Rules 6.6.6.g (if more than one relay is used in team competitions, then team members must be distributed equitably between the relays) and therefore 6.6.5.a (Start lists with firing point and relay allocations must be published and distributed <u>not later than</u> 4.00 PM on the day before Pre-Event Training for that event).

Registration deadlines

Please complete the attached Registration Forms (Annex 1 - 7) and return them by the established deadlines. (The Summary of Deadlines is also enclosed).

Notes:

<u>First Entry (by number)</u>: Via SDMS NPCs must submit the total number of athletes and team officials participating, and the number of the entries estimated per individual and team events.

Cancellation:

Any World Shooting Para Sport Member Federation reducing the number of athletes and /or officials after the Official Entry Deadline (2 SEP 2018) is obligated to pay all applicable fees and costs including entry fees according to the number of starts on the Final Entry Forms originally received. If the applicable fees and costs are not paid no member of that federation may participate.



Fees:

Entry Fee Athletes EUR 250,00 per person per event.

The Entry Fees include all charges for registration, competition targets, doping, transport from/to the official airport, and local transportation between the shooting range and the official hotels. The Entry Fees DO NOT include the cost of the Pre-Event and Unofficial Trainings.

Para Trap training rounds EUR 8,00 per round

Fee Officials EUR 120,00 per person (Team Leaders, Team Officials, Coaches, Media, Companions,) inclusive of transportation from/to the official airport, and local daily shuttle between the venue and the official hotels.

Payment of Entry Fees

Registration and payment of the Entry fees will be made at the shooting range prior to the collection of start numbers, or Swift prior to arrival.

Payments can be made either in Euro or US Dollars.

Credit cards or personal checks will \underline{not} be accepted.

Payment for accommodation must be made directly to the hotels.

Accreditation Process

All persons involved in the event (Athletes, Team Officials, ISSF Officials, OC Officials, Media) must have accreditations that clearly identify the accreditation holder (with photograph, family name and first name, nation and function) in order to use the local transportation and to enter controlled areas on the shooting range.

Accreditations (for persons registered before the Final Entry Deadline and with a photograph in the World Shooting Para Sport database) will be prepared by the World Shooting Para Sport Headquarters and Organizing Committee. All other accreditations will be prepared by the Accreditation Office at the event.

Accreditations and BIB Numbers will be distributed by the Organizing Committee after payment of the entry fees.



6. Venue and Facilities

The Championships will be held at the "Trap Concaverde" Shooting Club in Lonato D/Garda (Brescia), Italy.

Trap Concaverde is situated in the tourist Southern Garda Lake District, at a distance of 8 km from Desenzano, 30 km from downtown Brescia, and 40 km from Verona.

Directions: Highway A4 Milano/Venezia, Exit: Desenzano. Turn to the right side and proceed for 5 km then first exit on the right side (direction Castiglione D/Stiviere; you will immediately see the panel board of the Shooting Club. At the round-about keep the right and drive straight for about 500 m.

The ranges available for the event are seven (7). They are equipped with Mattarelli machines and Elfipa acoustic release systems.

All ranges are equipped with Elfipa electronic scoreboards.

The firing direction of the shooting range is north/north east.

The targets used for the event are Eurotarget standard orange for the Qualification and flash orange for the Finals.

Catering

Trap Concaverde Shooting Club is facilitated with bar and restaurant offering drinks, refreshments, a self-service buffet at reasonable prices, and meals with menu "à la carte". Reservations are not necessary.

Specific dietary requirements should be advised to the Organizing Committee by the Final Entry deadline. Every effort will be made to cater to your requirements if sufficient notice is given.

7. Immigration and Customs Requirements

Entry Visa

EU Nationals are able to enter Italy with a valid passport or with a valid ID Card.

Countries that require an Entry Visa for Italy should apply to the Italian Embassy/Consulate in their Country largely in advance before departure. The Italian Shooting Federation has no influence on the Embassies and will only be able to provide invitations for the period of the World Shooting Para Sport Championship and eventual pre-event training.

No Visa will be granted upon arrival at the airport.

Custom Formalities, Import of Firearms

A maximum of three (3) shotguns and 1200 cartridges are allowed to enter in Italy for sport competitions.



European Union nationals holding a "European Shotgun Certificate" can import to Italy their firearms without an auxiliary permission; however they are requested to fill in the "Firearm & Ammunition Form" for Local Police security reasons. Upon receipt of the form duly filled in, the athletes travelling by plane will receive a nominative invitation letter to show the Police and Customs Authority together with the European Shotgun Certificate at arrival.

Athletes, NOT holding a "European Shotgun Certificate" immediately upon receipt of the "Firearm & Ammunition Form" duly filled in, will be sent the FITAV permit to be shown the Police and Customs upon arrival in Italy.

All the athletes travelling by plane have to fill in an additional double copy declaration on arrival at the Italian airport. (As complimentary O.C. staff members will do it on their behalf). This form, together with the FITAV permit, at departure from Italy, must be returned to the Police Officers.

This paragraph might be subject to amendments independently from the means of transport. In that case, the Organizing Committee will immediately inform all the IPC Member Federations.

<u>Non-European Union</u> citizens are also advised to take with them a copy of their passport which will be handed to the Police station together with the other forms at arrival, in order to speed the procedure.

Please DO NOT send any passport copy to the Organizing Committee

Police and Customs firearms formalities will take place upon arrival at the first airport on Italian National Territory and at the last one at departure.

The Organizing Committee will not be responsible with the Italian Police at the airport for any incorrect information provided by the NPC related to firearms and ammunition.

Any request to change the shotguns details after the deadline must be notified to the Organizing Committee until seven (7) days prior to arrival. Changes after that date will not be accepted.

Useful Information on the carriage of shotguns and ammunition on International Flights

As a rule before issuing any ticket the travel agency appointed to book the flights must make sure that both ammunition and the firearms are accepted on board the aircraft till the final destination.

The approval should appear in the electronic ticket (on the PNR Passengers Name Record) or on a separate message sent to the travel agency by the Airline Company.

The rules governing the carriage of ammunition and firearms are those of the Carrier who owns the aircraft therefore in case of flights made in code-sharing, the approval must come from both companies even if on the ticket the abbreviation of only one Company appears (i.e. AZ - AF - KL, EI, LH, etc).

Normally, the final decision to accept firearms and ammunition on board comes from the Captain/Airline Company, but once you have the "OK" on your flight ticket, the Company is responsible for having your firearms sent to destination.

In case of indirect flights it is advisable to consider a connection of at least two hours. Upon landing at the first airport, report to the information counter and make sure that your firearms have arrived and will be taken on board of the connecting flight.

Still in case of indirect flights, <u>avoid booking</u> them with two different Airline Companies as most of the times the firearms will be discharged and let at the first airport and the owners will have to collect them and make a new check-in, provided the local Police and Customs Authorities do not cause problems of licenses. That will probably cost extra security and boarding tax and, sometimes, extra-baggage fees. If passengers are not



informed they risk to arrive at the final destination without knowing that their shotguns have not been loaded on the connecting flight and are laying in the previous airport.

In many countries even in transit and the baggage is labeled till destination, the control of firearms is made at the first airport of arrival and this is why it is advisable to keep the situation under control step by step.

All firearms and ammunition must be declared while making flight reservation and at check-in and follow the procedure reserved to these special articles. It is a big mistake to pack them into normal bags and dispatch them as normal baggage because in case of loss it will be very difficult to find the firearms in a short time and, last but not least, owners will be liable to heavy fines.

As for Italy, Police and Customs formalities for ammunition and firearms must be dispatched at the first airport of arrival on the Italian Territory. They will be taken by the Security guards to the Police station located inside the international area where each gun's holder will collect them and, if the airport of arrival is not the same of destination, it will be necessary to make a new police control and a new check-in at the domestic departure area.

To avoid such a big trouble, we suggest all the athletes direct to Lonato Del Garda to book their flights in order to land directly at one of the Northern airports listed in section 9 of this General Information even if <u>not</u> all of them are considered as "official airports " for the event.

In NO case ammunition is allowed to be packed on carry-on baggage or with the firearm. It must be packed into a separate ammunition box matching IATA Regulations (polythene - metal - wooden).

Firearm Security Tax – Firearm Boarding Tax

At departure from Italy depending on the different Airline Companies, airport and destination, passengers will be charged a "Firearm Tax" and/or an additional "Security Tax" for their shotguns. At Verona airport the "Security tax" is charged also at arrival.

8. Accommodation

Official Hotels

The Delegations will be accommodated in the following 3^{***} and 4^{****} star hotels situated at the distance of 8-10 km. (10/15 minutes drive) from the venue

Rates are intended per room per night and include buffet breakfast, service and tax.

<u>The Tourist Tax of approx. EUR 1.00 per person per night is not included in the rates and wherever requested, is</u> to be paid directly in hotel,

The hotel positioned in Desenzano city centre, is not facilitated with restaurant but lakeside and main streets offering a wide range of bars, restaurants, pizzeria, and more, are only a stone's throw away.

Facilities: 4 rooms for disabled people (the shower box in the bathrooms of the other rooms is not accessible to wheelchair) free wi-fi connection garage terrace with panoramic view.

-Further descriptions of all the hotels will be provided on request or can be viewed on the hotels' websites.

Half Board in hotels with restaurant is optional.

It is strictly forbidden to cook in the hotel rooms. Reservations must be made through the Organizing Committee and would be on a first come, first serve basis.

IMPORTANT:

Also in October hotels situated in the Garda Lake area are very demanded by tourists, for conventions, exhibition and other events so, be aware that the "goodwill regulations" for cancellations, no-shows or earlier check-out, <u>will not be possible</u>.

Accommodation for early arrivals and days outside the World Championships should be booked in advance; please contact the LOC to make arrangements.

We also recommend sending the Hotel reservation forms by the deadline as we cannot guarantee the rooms after that date.

Final Hotel Reservation must be effected by 2 AUG 2018



Payment for accommodation must be made directly to the hotels

-A 50% deposit by 2 SEP 2018 is mandatory.

-The hotels will be ready to provide pro-forma invoices for pre-payment purposes. -The balance is requested to be settled upon arrival or swift in advance.

-Bank fees are at the participants' expense.

-The Chief of each Delegation and individuals are responsible for paying any extra hotel charges.

-Any change or cancellation must be notified to the Organizing Committee.

Penalty fees for cancellation:

Free cancellation is possible till 2 SEP 2018

-from 3 SEP to 24 SEP 2018 the penalty amounts to the 50% of the total cost for any reserved and then cancelled room.

-from 25 SEP 2018 onwards the penalty fee will be equal to the 100% of the total cost for any reserved and then cancelled or not occupied room.

NO penalty for cancellation will be charged by the hotels in case the O.C. can replace the cancelled reservations with others.

9. Travel and Transportation

Travel – Arrival

 Airport pick up – Transportation to the Official Hotels (and return for departure)
The Official airport for the event is MILANO MALPENSA (MXP) - the distance to the range is 165 km.

Round trip from/to Malpensa airport and the Official Hotels, will be arranged by the OC.

The service will be active as from 30 SEP 2018

All the delegations will be assisted to dispatch the Police and Customs procedures and escorted to the bus. Travellers will meet the assistants near to the baggage collection upon arrival. On request transportation will also be arranged from/to Verona Airport (40 Km from the Venue) but without any assistance inside the airport.



Transportation from/to other airports (Milano Linate –LIN and Bergamo –BGY) can be arranged by the O.C. at the Delegations' expense.

Transfers from and to the airport, and assistance during the period, (**30 SEP-7 OCT 2018**) will be provided based on the arrival and departure dates declared in the Final Travel Form as this is covered within the Basic Entry Fee.

Teams travelling <u>outside</u> 30 SEP–7 OCT have to make their own arrangements or contact the Organizing Committee that, at the Delegation's expense, will arrange assistance and/or transportation.

<u>All transportation services requested in the "Final Travel Form", not cancelled within two (2) days before arrival, will be applicable by the Organizing Committee according to the number of passengers appearing in the "Final Travel Form" for which the service has been required.</u>

The Organizing Committee will not refund or be in charge for any taxi fare payment.

No transportation will be provided to the participants lodged in unofficial hotels.

Hotel-Venue Daily Shuttle Service

An accessible bus service is covered within the Basic Entry Fee and will operate between the official hotels and the Venue for the duration of the competition (1– 6 OCT 2018)

In case of accommodation in unofficial hotels, the local transportation has to be arranged by the participants.

10. Competition Related Procedures at the Shooting Range

Technical Meeting

The Technical Meeting will take place on 4 OCT 2018 at the shooting range.

Each participating World Shooting Para Sport Member Federation should have at least one representative present to receive updated information regarding Final Competition Schedule (including Training Schedule), draw procedures and other important issues related to the event.

Storage of Firearms and Ammunition

Storage of guns and ammunition is available at the armory on the shooting range. Athletes are also permitted to take their shotguns in the hotel room provided they do not let them unattended.

Ammunition

The Italian Customs Authority will allow each athlete to import a maximum of 1.200 pcs. cartridge which will be used for the competition.

The use of steel pellets is not allowed.

A wide range of local and international ammunition will be available for sale at the shooting club.

11. Ceremonies

-The **Opening Ceremony** will take place at the Shooting Club on **4 OCT. 2018** in the late afternoon. A welcome buffet will follow.

-The **Closing** Ceremony will take place at the Shooting Club on 6 OCT. 2018 after the last Victory Ceremony. A closing buffet will follow.

-The Victory Ceremonies will take place at the shooting range immediately after the end of each Final.

During the ceremonies the athletes are required to present themselves in their official national uniform or national tracksuits (tops and bottoms).

12. Insurance

Please note that all participants (athletes and team officials) attending the event must ensure they have an appropriate personal medical and travel insurance, as the event will not indemnify individual claims. The LOC will not cover any illness cases.



13. Doping Control

Doping Control will be conducted according to the IPC anti-doping code.

14. Weather Information

The climate conditions in October are variable, rain alternates with sun. The average temperature is expected to be 18°/20° degrees Celsius during the day and 15°/17° degrees Celsius in the night

15. Media Relations

All Media representatives must register for the Para Trap World Cup by using the Media Accreditation Form (Annex 7).

Press conference will take place prior, during and at the end of the event. Press and Television service will be given during the event.
