COVID MEASURES

Entry requirements for the Chateauroux 2022 WSPS World Cup:

Important Context for sport international event in France and for this World Cup

French legislation applies to foreign athletes who come to France in order to participate in an international sporting event.

All competitors and officials must :

- **Be vaccinated – including WHO and EMA’s non-recognized vaccines**
- **Or Present a Certificate of Recovery**
- **Or Present a Medical Certificate of Contraindication to Vaccination**

Non-vaccinated persons or people who don't respect conditions above won't be able to take part in the competition as shooter or official.

A proof of the vaccination (or certificate of recovery or medical certificate) of each participant will have to be sent to the LOC before the **10th of May 2022 with the “Covid information Form”**. All these informations will be sent by LOC to French Health Authorities.



2 – COVID competition additional rules for this World Cup

- The wearing of a mask will be compulsory in all areas of the shooting range.
- On arrival at the shooting range on the first day athletes and professionals will have to do one PCR or one antigenic testing. This test is **mandatory** to participate in the competition. After receiving a negative result, athletes and professionals will be given a permanent bracelet to be kept during the all competition. This test will be charged on a maximum fee of 50 €/person.
- The chief of delegation for each country will be nominated as “Covid responsible” for its all team. He will sign an engagement to signal to the LOC all type of symptom coming for a member of its team.
- In the event of a positive test, the procedure for isolation and management of contact cases, as defined by the Ministry of Solidarity and Health, is implemented.
- For the return trip, the LOC will be able to organize PCR tests that will be asked at the airport. A date will have to be scheduled for that between the chief of delegation and the LOC.



3 – Rules to enter France (different from the WC entry requirements!)

Since the beginning of the crisis, the border health control system has made it possible to protect our health system and to delay the arrival on national territory of variants with worrying characteristics.

This system, which mobilizes nearly 6,000 members of civil security each week to carry out the tests, border guards to check the health documents of travelers and internal security forces to check the isolation or quarantine measures decided by prefects, is regularly adapted to changes in the health situation and community rules.

Faced with the new phase of the pandemic characterized, in most countries, by the predominance of the Omicron variant and a high level of vaccination, the Government has decided to lighten this health control system at the borders, particularly for vaccinated travellers.

Since February 12, 2022, the following rules apply at borders :

- For travelers vaccinated within the meaning of European regulations, no more tests is required on departure. Proof of a complete vaccination schedule becomes sufficient to arrive in France, regardless of the country of origin, as was the case before the distribution of the Omicron variant.
- For unvaccinated travellers, the obligation to present a negative test to travel to France remains, but the measures on arrival (test, isolation) are lifted when they come from countries on the "green" list, characterized by a moderate circulation of the virus.
- When unvaccinated travelers come from a country on the "orange" list, they must continue to present a compelling reason justifying the need for them to come to mainland France and may still be subject to a random test on arrival. Travelers who test positive will have to isolate themselves, in accordance with the recommendations of the Health Insurance.

In the event of an emergency characterized by the appearance of a variant likely to present a risk of increased transmissibility or immune escape, the "emergency brake" mechanism will be activated and the country will then be placed on the "red" list, implying, as is the case today, the obligation to present a compelling reason for travelling, the obligation to present a negative test on departure - including for vaccinated travelers in the event of a variant presenting the characteristic of an escape immune-, and the obligation to undergo a test on arrival conditioning the placement in quarantine decided by the prefects and controlled by the police.

Such classification will be temporary and reviewed regularly to ensure the proportionality of the travel restriction measures. Currently, no country is classified in the "red" list.




These border rules may be adapted in view of the evolution of the health situation, and in line with the work currently being carried out with our European partners.

On the other hand, given the health situation of the Overseas Territories, the health control procedures for accessing them remain unchanged at this stage.

The current classification of countries, defined on the basis of health indicators, is as follows:

- “Green” countries : countries or territories with negligible or moderate circulation of the virus, in the absence of emerging variants of concern. These are the countries of the European area: Member States of the European Union as well as Andorra, Iceland, Liechtenstein, Monaco, Norway, San Marino, Switzerland and the Vatican. In addition, the following countries and territories are added: South Africa, Albania, Angola, Antigua and Barbuda, Saudi Arabia, Argentina, Aruba, Azerbaijan, Bahamas, Bahrain, Bangladesh, Barbados, Belize, Benin, Bolivia, Bonaire, St. Eustatius and Saba, Bosnia and Herzegovina, Botswana, Bhutan, Burkina Faso, Burma, Burundi, Brazil, Cambodia, Cameroon, Canada , Cape Verde, Chile, Colombia, Comoros, Congo, Ivory Coast, South Korea, Costa Rica, Cuba, Curaçao, Djibouti, Egypt, United Arab Emirates, Ecuador, Eswatini, United States, Ethiopia, Fiji, Gabon, Gambia, Ghana, Guinea, Equatorial Guinea, Guinea Bissau, Grenada, Greenland, Guatemala, Honduras, Hong Kong, Faroe Islands, Mauritius, Solomon Islands, Turks and Caicos Islands, British Virgin Islands, US Virgin Islands, India, Indonesia, Iraq, Jamaica, Japan, Jordan, Kazakhstan, Kenya , Kiribati, Kosovo, Kuwait, Laos, Lesotho, Lebanon, Liberia, North Macedonia, Madagascar, Malaysia, Malawi, Maldives, Morocco, Mauritania, Mexico, Moldova, Mongolia, Montenegro, Montserrat, Mozambique, Namibia, Nepal, Nicaragua, Niger, Nigeria, New Zealand, Oman, Uganda, Pakistan, Panama, Papua New Guinea, Paraguay, Peru, Philippines, Puerto Rico, Qatar, Democratic Republic of Congo, Dominican Republic, United Kingdom, Rwanda, Saint Kitts and Nevis, Saint- Lucia, Saint Vincent and the Grenadines, El Salvador, Samoa, Sao Tome and Principe, Senegal, Serbia, Seychelles, Sudan, South Sudan, Sri Lanka, Taiwan, Tanzania, Chad, East Timor, Togo, Tunisia, Turkey, Trinidad and Tobago, Ukraine, Uruguay, Vanuatu, Venezuela, Vietnam, Zambia and Zimbabwe.
- “Orange” countries : countries or territories experiencing active circulation of the virus, in the absence of an emerging variant of concern and showing no vaccine or immune escape. These are all countries not included in the list of “green” countries.



For Green area

The vaccination schedule is considered complete 28 days after receiving one dose of Janssen vaccine, seven days after a second dose of other vaccines approved by the European Medicines Agency (namely Pfizer/Comirnaty, Moderna, AstraZeneca/Vaxzevria/Covishield) and, for persons who have received all the required doses of a WHO-licensed vaccine not approved by the European Medicines Agency, seven days after receiving an additional dose of a duly approved mRNA vaccine.

Since 1 February 2022, in order for their vaccination schedule to continue to be recognised as complete, persons aged 18 years or older wishing to enter French territory must have received a booster dose of messenger RNA vaccine no later than nine months after receiving the last mandatory dose.

Mobility rules and regulations

No restriction shall apply when entering metropolitan France from a green list country or territory. No compelling reason is required for travelers to France.



Health control measures

Should you wish to enter the national territory from a “green” list country or territory :

- No negative test on departure is required on departure for vaccinated travelers within the meaning of European regulations. These travelers must present proof of this vaccination to the transport company and to the border control authorities.
- Unvaccinated travelers must present a negative result of a PCR test less than 72 hours or an antigen test less than 48 hours before departure (departure of the first flight in the event of a connection), or a certificate of recovery (positive result of a PCR or antigen test carried out more than eleven days and less than six months previously. This certificate is only valid for a period of six months from the date of the examination or test).
- No measures (tests, isolation) are in force upon arrival in metropolitan France.

Given the health situation in the overseas territories, these rules may vary in the overseas departments and territories: travelers are therefore invited to consult the websites of the prefectures and High Commissions concerned.

Admission to stay

Travellers must present documents proving that their stay in the Schengen Area is legal.

All foreign travellers must present with the usually required documents:

- **For a short stay (less than 90 days) :** Proof of resources and accommodation, and a short stay visa if applicable to their nationality;
- **For those planning to settle in France :** A long-stay visa;
- **For those residing in France :** A residence permit.



For Orange area

The "orange" list includes countries or territories experiencing active circulation of the virus, in the absence of an emerging variant of concern and showing no vaccine or immune escape. These include all countries not listed as “green” countries.

Applicable rules depend on the traveller’s vaccination status.

The list of orange list countries classified by decree of the Minister of Health, may be amended according to how the global outbreak status evolves.

The vaccination schedule is considered complete 28 days after receiving one dose of Janssen vaccine, seven days after a second dose of other vaccines approved by the European Medicines Agency (namely Pfizer/Comirnaty, Moderna, AstraZeneca/Vaxzevria/Covishield) and, for persons who have received all the required doses of a WHO-licensed vaccine not approved by the European Medicines Agency, seven days after receiving an additional dose of a duly approved mRNA vaccine.

Since 1 February 2022, in order for their vaccination schedule to continue to be recognised as complete, persons aged 18 years or older wishing to enter French territory must have received a booster dose of messenger RNA vaccine no later than nine months after receiving the last mandatory dose.

Mobility rules and regulations

Vaccinated persons shall be under no restrictions when entering metropolitan France.

Unvaccinated persons travelling from an “orange” list country must justify the need for their trip, corresponding to a compelling reason.

Health control measures

If already vaccinated :

- proof of vaccination status; Since February 1, 2022, in order for their vaccination schedule to remain recognized as complete, persons aged eighteen or over wishing to enter the national territory must have received a dose of complementary messenger



RNA vaccine no later than 9 months following the injection of the last required dose.

- a sworn statement attesting to the absence of symptoms of covid-19 infection and contact with a confirmed case of Covid-19 to enter the metropolitan territory.

No test is required to travel to mainland France from a country classified on the “orange” list for vaccinated travellers.

If you are not vaccinated :

- you must show the transport company and the border control authorities the negative result of a PCR test less than 72 hours or of an antigen test less than 48 hours before departure (departure from the first flight in the event of a connection).
- you must have a sworn statement attesting to the absence of symptoms of covid-19 infection and contact with a confirmed case of Covid-19 to enter the metropolitan territory and your commitment to accept a possible screening on arrival.
- you may be screened upon arrival. If this screening is positive, you will have to self-isolate, in accordance with the recommendations of the health insurance : <https://www.ameli.fr/assure/covid-19/symptomes-gestes-barrieres-cas-contact-et-isolement/en-cas-de-test-positif-au-covid-19>

Given the health situation in the overseas territories, these rules may vary in the overseas departments and territories: travelers are therefore invited to consult the websites of the prefectures and High Commissions concerned.

Admission to stay

All foreign travellers must present a valid passport at the border, together with the usually required documents:

- **For a short stay (less than 90 days) :** Proof of resources and accommodation, and a short stay visa if applicable to their nationality;
- **For those planning to settle in France :** A long-stay visa;
- **For those residing in France :** A residence permit.

Monsieur le Président,


