

Paralympic Villages Polyclinic Services

- Polyclinic Operating Dates and Scope of Services
 - Emergency services available 24/7
 - Full services between 07:00 and 23:00
 - Emergency and first aid services available during the pre-opening (March 1 – March 3) and post-closing ceremony (March 22 – March 24) periods
- Polyclinic Services (Vancouver and Whistler)

Paralympic Villages Polyclinic Services continued

- Emergency medicine and trauma care
- Primary care / Sport medicine
- Diagnostic Medical Laboratory
- Imaging
- Pharmacy
- Dental, Eye, ENT clinics
- Specialist consultants / clinics
- Nutrition and sports psychology
- Emergency Medical Unit (EMU)
 - Whistler Polyclinic
 - Surgical capacity for life, limb or organ salvage or when Whistler cut off by road and air

Paralympic Villages Polyclinic Services continued

- Therapy physiotherapy, massage therapy, chiropractic, rehabilitation and recovery centre
- Podiatry, orthotics and bracing
- Wheelchair, sledge and prosthetic repair
- Physical and rehabilitation medicine
- Hoists
- Public Health monitoring and reporting
- Interpretation services

Regeneration and Recovery

- New service offered to athletes during the Games
- Located within the fitness centers of each Village (Vancouver and Whistler)
 - One hot and one cold 4-6 person whirlpool
 - 4 stationary bikes
 - 4 massage tables
 - Stretch area (stretch cords, foam rollers)

Paralympic Villages NPC Medical Space

- Bookable medical spaces for smaller delegations (1 – 10 persons)
- Ice and towels at Village resident centres
- Recycling and biomedical waste disposal

Venue Medical Services Athletes

Athlete Medical Stations

- At all competition and training venues
- Emergency, primary care and sports medicine
- Staffed by physicians, nurses and therapists
- Equipment repair services

Field-of-Play (FOP) Response

- On-site evaluation
- If necessary, removal from FOP and transport to athlete medical station, Village polyclinic or hospital
- FOP response in accordance with IPSF rules

Venue Medical Services Spectators

Spectator Medical Stations

- First aid and emergency medical services
- Staffed by physicians, nurses and first aid providers

Venue Medical Services Medical Transportation


- Ambulances and crew stationed at competition and non-competition venues during operating hours
- Emergency transport from venue to Village polyclinic or designated hospital depending on severity
- Whistler venues supported by Critical Care Transport (CCT) helicopter





- One Health Authority covering all Paralympic venues
 - Consistent level of care across facilities
 - Communication between facilities
 - Real time consultation and communication to VANOC
- Vancouver General Hospital Paralympic Family Hospital
- St. Paul's Hospital Main Spectator Hospital

Medical Services Hospitals



NPC Health Care Personnel Licensing

- NPC health care personnel may only treat members of own delegation except with prior written agreement between NPCs
- NPC Chief Medical Officer is responsible for:
 - Providing complete list of health care personnel
 - Guaranteeing that all NPC health care personnel are qualified, registered and have malpractice insurance (where applicable)
 - NPC physicians will then be registered and given specific privileges
 - Need a list and contact details for all NPC CMOs (Results and study)



Registered NPC physicians may:

- Request therapy services and diagnostic tests at Paralympic Village polyclinics
- Write prescriptions for Paralympic Village pharmacies
- Have visiting privileges but no treatment privileges at hospitals

Anti-Doping Program: Mission

- Deliver a state-of-the-art doping control program at the 2010 Games to ensure all athletes can compete on a level playing field.
- Leave a legacy by developing and implementing a leading anti-doping program focusing on pregames information and awareness programs to promote the values of doping free sport.
- Doping-free Games.

Anti-Doping Program: IPC

- Under the authority and jurisdiction of the IPC Anti-Doping Code
- Consistent with the World Anti-Doping Agency (WADA) Code, WADA Prohibited List and the WADA Standards
- Doping control delegated to VANOC
- Athlete Whereabouts, Therapeutic Use Exemptions and Results Management IPC responsibility

Anti-Doping Program:Detection and Deterrence

- 425 tests at the Paralympics (both blood and urine)
- Testing conducted anytime anywhere from March 6
 - March 21
- Intelligent Effective Test Planning

Anti-Doping Program: Detection and Deterrence

- On-site state-of-the-art WADA accredited laboratory at Richmond Olympic Oval
- Latest WADA approved analytical techniques including urine and blood analysis
- Most advanced technological scientific instrumentation
- 15,000 square feet including wet laboratory, instrumentation room and office areas



Anti-Doping Program:Detection and Deterrence

- Cooperation with law enforcement agencies
- Integration with security, waste management and cleaning
- Highly experienced Doping Control Officers, Blood Collection Officers and Chaperones
- Large Doping Control Stations located at each competition venue and each village
- Daily medal transfers (WOP and Alpine)



Leave a legacy by developing and implementing a leading anti-doping program focusing on pre-games information and awareness programs to promote the values of doping free sport.

Anti-Doping Program: Education and Resources

- IPC Anti-Doping Code
- VANOC Technical Procedures for Doping Control and General Anti-Doping Information published in fall 2009
- Anti-Doping resources provided to NPCs in fall of 2009
- WADA Prohibited List comes into effect in January 2010



Advice for Observers



- Plan early
- Ensure you have experienced doping control staff
- Significant training programs
- Large doping control stations with many processing rooms
- Education (not just of athletes and support personnel) media, border officers, cleaning and waste
- Partnerships WADA, International Sport Federations, etc
