# Anti-Doping

The Anti-Doping control / processes may be carried out in full accordance with the IPC Anti-Doping Code and the IPC Doping Control Agreement.

The anti-doping rules of IWA-Sport are the Irish Anti-Doping Rules as amended from time to time.

#### **Medical Information**

The LOC will ensure the implementation of all necessary and appropriate on-site medical, emergency ambulance and first aid services during training days and the competition. For medical treatment no medical insurance will be provided to any participants. All participants are responsible for obtaining their own medical insurance (including Repatriation Coverage) and will be responsible for any medical expenses resulting from participation in the event. Each NPC must ensure that all members of their delegation are appropriately insured, including coverage for travel, liability, accidents, and repatriation.

#### Section 4 - Anti doping declaration and therapeutic use exemption form

- It is a condition of this Competition that all athletes participating must declare compliance with the Irish Anti-Doping Rules.
- Primary responsibility for ensuring that substances on the World Anti-Doping(WADA) banned list are not taken, rests with each individual athlete.
- If an athlete is taking, for medical reasons, a substance on the WADA prohibited list or is using a method prohibited by WADA, then he/she must complete the below Therapeutic Exemption Form and submit it to the organiser at least one hour before the start of the event. If this is not completed and the substance is detected during the doping control procedures, the sports person will be liable to the relevant disciplinary procedures.

#### Consent

### What information does IWA collect from you?

# Why does IWA collect this information?

#### Are IWA allowed to collect and process my information?

Yes, IWA have a legitimate interest in collecting and processing of your personal data for the administration of business, and to comply with Company Law

(We rely on GDPR Article 6 1 (F) to process your standing information, name, address, and Article 9 2 (B) to process any sensitive data, such as medical data.)

#### Where does IWA get this information?

IWA collects this information directly from you when you register to take part in our activities. This can include lifelong membership or one off visits.

#### Whom does IWA share this information with?

IWA will use this data for the purposes of administering our relationship with you, as a valued IWA Member, IWA Sports Member, Volunteer, or Staff member, and to provide you with information about areas of interest to you and about our services generally. IWA will not, without your knowledge, supply your data to any third party except where such a transfer is a necessary part of the activities, which, we undertake as an organisation, for example, updating our funders, or to facilitate services provided on behalf by our GDPR compliant third parties.

#### How long does IWA keep your information?

Typically, IWA will keep your data for seven years, while you are engaging with IWA, and for seven years after you stop engaging with IWA.
