2025 IPC Athlete Registration and Licensing Programme

Dear NPC Presidents/Secretaries General,

We open the system for NPCs to register and license athletes for the 2025 season (1 January 2025 to 31 December 2025) on 18 October 2024.

The purpose of this letter is to formally commence the athlete registration and licensing process for the 2025 season for the World Para Summer Sports currently governed by the IPC, and to remind you of key aspects of the process (including changes put in place since the 2024 season).

1 LICENCE FEES

The World Para Summer Sports have seen significant growth in licensing since 2012. As a consequence, we restructured the licensing programme format in 2017 and introduced a licence fee per sport (athletics, powerlifting, shooting, swimming) per NPC, replacing the previous package-based, all-sport system.

The current licence fee (on a per-sport basis) is invoiced annually and allows access to an UNLIMITED number of licences for your NPC in the relevant sport for the season. The licence fee charged per sport per NPC has been calculated based on the number of licences activated per season in the previous Games cycle (2020-2023). The unlimited licence packages allow immediate licensing after confirmed registration.

The fee that is charged per NPC, per sport is calculated as the average number of licences (rounded) activated in the sport per season, multiplied by \leq 15 Euro per licence, plus a \leq 20 Euro fixed fee to cover any administration costs (bank charges etc.) that the IPC may incur.

NPCs do not need to apply for any licence package or invoice. An invoice for licences per sport will be created automatically by the IPC Sport Data Management System ("SDMS") at the start of each season and should be downloaded by the NPC via SDMS (*Licences & Invoices > packages*).

Please transfer the amount in question to the account indicated on the invoice. If the package is bought and athletes are licensed before 31 December 2024 their licences are valid from 1 January 2025 onwards. After 1 January 2025, the licences will be active from the date of activation.

Please indicate the invoice number on the payment form. The IPC has previously faced some problems in tracking payments, leading to a delay in activating licences. We kindly request you to send a proof of payment immediately to the IPC Finance Department at <u>accounts@paralympic.org</u> if your payment is not confirmed in SDMS within one week.

NPCs that face difficulties in transferring money due to policy limitations on the international transfer of funds should please contact the IPC Finance Department (accounts@paralympic.org) before 16 January 2025 to identify a suitable payment option. Please also do not hesitate to contact the IPC Finance Department for any further questions regarding payments.

2 LICENSING PROCESS

There are two changes to the licensing process for 2025:

- All athletes who wish to obtain a licence will need to submit a valid form of photo identification which is within its expiration date (e.g. passport, ID card, etc). Any athlete who does not submit an up to date (i.e. current, non-expired), valid form of ID will not be relicensed.
- Only athletes with sport class status 'Confirmed' or with a 'Fixed Review Date' later than 1 January 2026 will be available for immediate relicensing. For all athletes with a different sport class status, the relevant World Para Sport will only confirm the athlete's registration status and open the athlete's licensing opportunity once all athlete registration data fields and documentation have been <u>fully and properly</u> completed by the NPC, and the sport has reviewed and approved all data and documentation (including without limitation any medical diagnostic information and other documentation that may be requested by the sport prior to scheduling the athlete for classification).

We would like to remind you of the following:

- Please see the applicable Rules and Regulations of the individual World Para Sports together with the Licensing Regulations of those sports for the detailed licensing and eligibility requirements of those sports.
- On 1 July 2021, version three of the IPC Athlete Eligibility Agreement (the "Agreement") was published. To be eligible to be licensed (or relicensed) it is a mandatory requirement for each athlete to enter into the newest version of the Agreement. Consequently, all athletes who wish to obtain a licence for summer season 2025 will need to acknowledge and agree to version three of the Agreement if not already done. Any athlete who does not agree to the terms of version three will not be relicensed.
- In order to facilitate the process of registering each athlete's acknowledgement to the Agreement, the **SDMS Athlete Portal** (the "**Portal**") has been launched.
- Athlete Identification Cards and seasonal Licence Cards can be printed out for the new summer season 2025. SDMS offers a section under 'Licence Management' to select licensed athletes and download their cards as PDF files for printing and distribution.
- An athlete needs to be licensed in order to proceed to Athlete Evaluation (classification).

- An athlete also needs to be licensed prior to a competition for their results to be recognised for rankings and records purposes (see the Rules and Regulations and Licensing Regulations of the individual World Para Sports for details).
- In accordance with the reminder letters send out by the World Para Sports in June 2024, NPCs are reminded that each athlete should only have <u>one</u> SDMS profile throughout their career.
- It is the responsibility of each NPC/NF to check whether an athlete has ever previously been registered and/or licensed, put forward for classification and/or competed in any World Para Sport (and therefore already has an SDMS profile). If so, the NPC <u>must</u> use the athlete's existing SDMS profile for all purposes relating to licensing/classification and/or competitions. This includes circumstances in which the athlete's SDMS profile has been changed to "retired" or "historic" status.
- NPCs/NFs should contact the relevant sport where they require an athlete's "historic" profile to be re-activated.
- NPCs/NFs must <u>not</u> create a new SDMS profile for athletes who have previously been registered and/or licensed, put forward for classification and/or competed for that NPC/NF (including in circumstances where the athlete's name or other details may have changed).

3 ATHLETE REGISTRATION PROCESS

A specific licensing guide is available online <u>here</u>. The detailed SDMS manual is available on <u>https://db.ipc-services.org/sdms</u>. In the following instructions guides are also considered as athletes.

3.1 ATHLETE REGISTRATION PHASE

The following steps are to be followed in the athlete registration process:

- 1. **NPCs access** the SDMS online with the same NPC Username and Password previously assigned. For NPCs that have not activated their account previously or are changing any of the users' data, please complete the NPC Account Request Form which can be found on the SDMS login page, underneath the login panel.
- 2. NPCs with active athletes registered or licensed for the 2024 season and who have already provided their agreement to the new IPC Athlete Eligibility Agreement (version three) will find all required athlete registration data fields and documentation available for review and ready to action, unless new documents have been uploaded that require review by the responsible World Para Sport. NPCs are kindly requested to replace

expired athlete passports with a new version as continued proof of nationality.

- 3. For NPCs adding new athletes and those without any athletes registered or licensed for any previous season, please complete the mandatory athlete registration data fields, and upload the following documentation for each athlete:
 - a. agreement to the IPC Athlete Eligibility Agreement (**version three**). The strongly recommended option is for the athlete to provide their agreement electronically in the SDMS Athlete Portal. Alternatively, the paper form can be signed and uploaded as per previous practice;
 - b. a recent passport size photo;
 - c. a copy of the athlete's passport or ID card. NPCs are reminded that the terms of the <u>IPC Nationality Regulations</u> apply to athletes in the World Para Sports (as referenced in the rules and regulations of the World Para Sports). Athletes who have already represented another NPC must comply with the process set out in the IPC Nationality Regulations (and referred to in the reminder letter sent by the World Para Sports to NPCs in June 2024) for a change of nationality <u>before</u> <u>they are permitted to compete</u> for their new NPC;
 - d. all fully complete and accurate classification-related forms and documentation, including without limitation any medical diagnostic information requested by the sport, as outlined in section 2 of this letter, uploaded to the Classification section of their SDMS profile.

Once all athlete registration data fields and documentation have been completed, eligibility conditions have been fulfilled, and the IPC has reviewed the data and documentation, the IPC will confirm the registration status and open the athlete's licensing opportunity.

In 2021, the IPC introduced the module on SDMS for submission of an Athlete's **Medical Review Request**. It is mandatory for NPCs to submit any Medical Review Request via SDMS. For more information and instructions please refer to the Guide available <u>here</u>.

3.2 ATHLETE LICENSING PHASE

The following steps are to be followed in the athlete licensing process:

 NPCs download and pay the invoice for an unlimited licence package as outlined above. Invoice recipient addresses might be subject to validation to ensure the accuracy and quality of addresses. Validation is required to ensure further processing of invoices in line with current accounting standards. 2. Once the package payment is confirmed NPCs select individual athletes for licensing.

The Athlete Licence is valid until 31 December 2025. It is important to refer to the Rules and Regulations of the World Para Sports together with any separate Licensing Regulations in order to understand the differences in an athlete's participation, results recognition for rankings and records and international classification between athletes not registered, registered or licensed.

In preparation for the 2025 athlete registration and licensing process, please find attached the user guide for the SDMS Athlete Portal and the IPC Athlete Eligibility Agreement (version three) for new athletes. General provisions for capturing and preparing photos and documentation for upload onto SDMS can be found in the SDMS manual on <u>https://db.ipc-services.org/sdms</u>.

4 CHANGE OF DATA PROTECTION OFFICER (DPO)

Please note that as of 1 March 2023, the IPC and the World Para Sports have a new data protection officer (DPO), replacing the previous DPO listed on the Athlete Eligibility Agreement. The new DPO's details are as follows:

Please ensure you inform all your athletes of the new DPO's details. The rights of World Para Sport athletes in relation to their personal data, as set out in the Athlete Eligibility Agreement, remain unaffected. Athletes should contact the new DPO if they have any questions about each World Para Sport's use of their personal data.

5 INVESTIGATIONS AND POTENTIAL DISCIPLINARY ACTION

As set out in the reminder letter sent by the World Para Sports to NPCs in June 2024, the World Para Sports and/or the IPC may investigate any misuse of the above licensing process and consider if potential disciplinary action is warranted.

This includes a situation where an athlete has been put forward for licensing under multiple SDMS profiles (including under a different name/identification document/personal details). This may also include investigation of an athlete who has been put forward for classification under multiple SDMS profiles/names for the offence of intentional misrepresentation. The athlete's support personnel and representatives of their NPC and/or NF may also be investigated for potential complicity in intentional misrepresentation.

In addition, the World Para Sports and/or the IPC may investigate any failure by an NPC to follow the procedures set out in the Nationality Regulations (for example by failing to declare that an athlete has previously represented another NPC) as a potential attempt to circumvent those Regulations, and consider any appropriate disciplinary action.

We hope that the above fully explains all processes and changes. If you have any problems in understanding the above, please contact the IPC.
