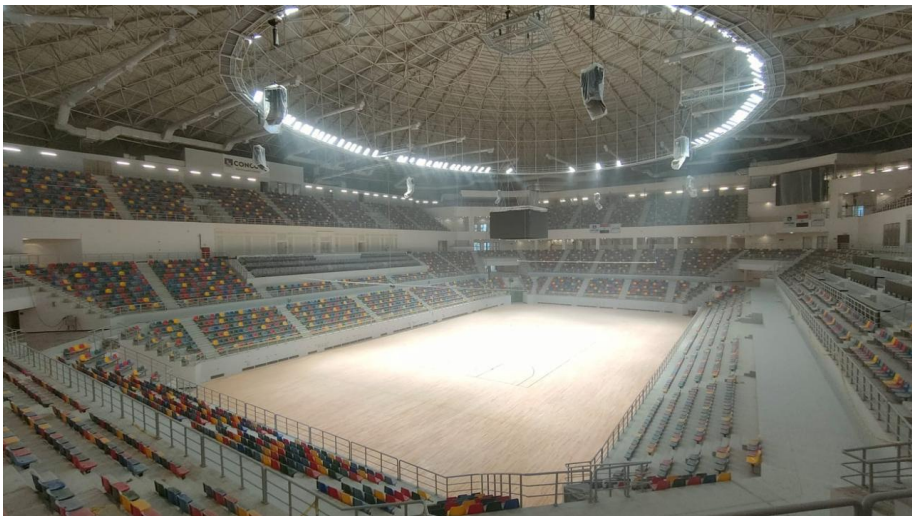
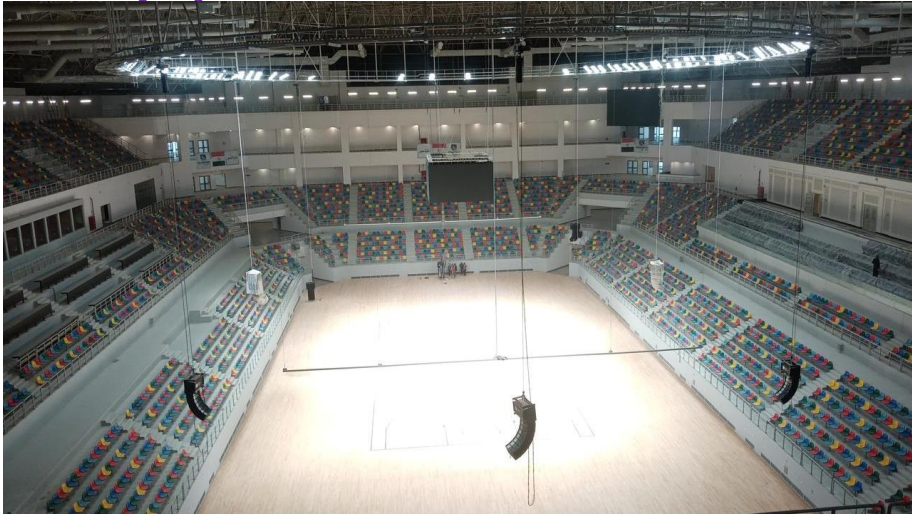

2. LOC to prepare and send to the NPC the Visa Invitation Letter.
3. NPC to make the necessary arrangements depending on the Visa needs for their country (i.e. e-visa procedures, embassy appointment, etc.).
4. NPC to inform the LOC and WPPO when they receive the visa.

# Transport

**Official World Championships airport:** Cairo International Airport (CAI)

- Distance between airport and World Championships hotel: 18 miles approximately
- Transportation time between airport and World Championships hotel: 45 min approximately
- Distance between World Championships hotel and Competition Venue: walking distance
- Transportation time between World Championships hotel and Competition venue: 2 min

Transportation will be provided free of charge to all athletes and team officials from/to the **official World Championships airport, and the official hotel on the official arrival and departure days**. Teams who arrive outside the official arrival dates can discuss with the LOC for transportation options\*.

Teams will be greeted by a LOC volunteer to help ensure they are delivered to the host hotel in a timely and safe manner.

*\*Please note that LOC is not obliged to provide transportation free of charge for teams arriving before official arrival days.*

# About Cairo

Cairo (/ˈkɑːroʊ/ KY-roh; Arabic: القاهرة romanized: al-Qāhirah, Egyptian Arabic pronunciation: [el.qɑ(ː)ˈheɾɑ]) is the capital and largest city of Egypt and the Cairo Governorate, being home to more than 10 million people. It is also part of the largest urban agglomeration in Africa, the Arab world and the Middle East. The Greater Cairo metropolitan area is the 12th-largest in the world by population with over 22.1 million people.

Cairo is associated with ancient Egypt, as the Giza pyramid complex and the ancient cities of Memphis and Heliopolis are located in its geographical area. Located near the Nile Delta, the city first developed as Fustat following the Muslim conquest of Egypt in 641 next to an existing ancient Roman fortress, Babylon. Cairo was founded by the Fatimid dynasty in 969. It later superseded Fustat as the main urban centre during the Ayyubid and Mamluk periods (12th–16th centuries). Cairo has long been a centre of the region's political and cultural life, and is titled "the city of a thousand minarets" for its preponderance of Islamic architecture. Cairo's historic center was awarded World Heritage Site status in 1979. Cairo is considered a World City with a "Beta +" classification according to GaWC.

Cairo has the oldest and largest film and music industry in the Arab world, as well as Egypt's oldest institution of higher learning, Al-Azhar University. Many international media, businesses, and organizations have regional headquarters in the city; the Arab League has had its headquarters in Cairo for most of its existence.

Cairo, like many other megacities, suffers from high levels of pollution and traffic. The Cairo Metro, opened in 1987, is the oldest metro system in Africa, and ranks amongst the fifteen busiest in the world, with over 1 billion annual passenger rides. The economy of Cairo was ranked first in the Middle East in 2005, and 43rd globally on Foreign Policy's 2010 Global Cities Index.

The New Administrative Capital (NAC) (Arabic: العاصمة الإدارية الجديدة, romanized: al-ʿĀṣima al-Idāriya al-Jadīda), is a new urban community in Cairo Governorate, Egypt and a satellite of Cairo City. It is planned to be Egypt's new capital and has been under construction since 2015. It was announced by the then Egyptian housing minister Mostafa Madbouly at the Egypt Economic Development Conference on 13 March 2015. The capital city is considered one of the projects for economic development, and is part of a larger initiative called Egypt Vision 2030.

The new capital of Egypt has yet to be given a name. A competition was launched on the new capital's website to choose a new name and logo for the city. A jury of specialists was formed to evaluate the proposals submitted to list and determine the best among all the proposals. No official results have yet been announced by the Egyptian Government. In October 2021, transportation minister Kamel al-Wazir indicated the city might be named "Wedian" (meaning "Riverbed" or "Valley"), or "Masr" (the Arabic equivalent of "Egypt"). Other proposed names include "Kemet," "Al Mustaqbal," and "Al Salam."

The new city is to be located 45 kilometres (28 miles) east of Cairo and just outside the Second Greater Cairo Ring Road, in a largely undeveloped area halfway to the seaport city of Suez. According to the plans, the city will become the new administrative and financial capital of Egypt, housing the main government departments and ministries and foreign embassies. On 700 square kilometres (270 sq mi) total area, it is expected to house a population of 6.5 million people, though it is estimated that the figure could rise to seven million.

The government stated that the undertaking of the project is to relieve congestion in Cairo. Cairo has a metropolitan population of nearly 20 million.

The Organising Committee will only accept entries submitted by the NPC / NF in good standing with the IPC. Furthermore, only those entries submitted by the NPC President, Secretary General, or authorised person will be processed. ## World Para Powerlifting Rules and Regulations

The most current World Para Powerlifting Rules and Regulations published upon the WPPO website alongside the World Para Powerlifting Qualification Pathway 2025-2028 will apply for this World Championships.

## Anti-doping

The Anti-Doping control / processes will be carried out in full accordance with the IPC Anti-Doping Code and the IPC Doping Control Agreement, further details can be found on the WPPO website: [www.paralympic.org/powerlifting/rules-and-regulations/anti-doping](http://www.paralympic.org/powerlifting/rules-and-regulations/anti-doping)

## Classification

The most current World Para Powerlifting Classification Rules and Regulations published upon the WPPO website will apply for this World Championships. All athletes who have a designated sport class status of New, Review, Review 2025 or earlier will be required to undergo International Classification prior to the start of the World Championships. A detailed classification schedule will follow after the revision of the final entries by WPPO.

## Medical information

The LOC will ensure the implementation of all necessary and appropriate on-site medical, emergency ambulance, first aid, and physiotherapeutic services throughout the World Championships. For medical treatment, no medical insurances will be provided to any participant during the World Championships.



## Participant Insurance

Each respective NPC is fully responsible to ensure that all members of their delegation are appropriately insured, including coverage for travel, medical, liability, accidents, Covid 19 and repatriation. Each NPC will need to provide evidence of appropriate insurance coverage for their full delegation by no later than 26 August 2025.

## Bodyweight Changes

Athletes will have the opportunity to change Bodyweight Categories during the entry verification process, either up or down one (1) Bodyweight Category from the category assigned at the time of the final entry deadline.

Only one (1) change per Athlete is accepted and must be requested during the allocated time of the entry verification process. A fee of one hundred Euros (€100) will be charged for each requested change and must be paid immediately during the entry verification process for the change to be accepted. The new Bodyweight Category is accepted only upon payment and is considered final.

## Lift Challenge Cards

At WPPO World Championships, Athletes will have the opportunity to challenge their own “No Lift” decision. The Lift Challenge cards must be requested from the entries open date until the Technical Meeting date at a cost of one hundred Euros (€100). Full payment must be paid immediately upon request of the Lift Challenge card/s. Any purchased Lift Challenge cards retained by an Athlete or Team Official must be returned to the WPPO management before the close of the World Championships in order to receive a full refund. Any Lift Challenge cards that are not returned in this timeframe will no longer be valid or eligible for a refund.

## Bodyweight Changes & Lift Challenge Card Payment

# World Championships Information

## Preliminary Programme

The Provisional timetable and events programme will be provided after the final entries by name deadline. The competition schedule will remain subject to change until the close of the technical meeting.

## Number of entries per event per NPC

## Individual events

There is no maximum number of entries per gender, Bodyweight Category and age group per NPC.

## Team events (Gender and Mixed)

In accordance with the most current World Para Powerlifting Technical Rules and Regulations published upon the WPPO website.

## Event Viability

Athletes may compete and/or be awarded medals in a single Bodyweight Category or combined categories as detailed below:

- 3 or more Athletes: All medals will be awarded (Gold, Silver, Bronze).
- MS rule: when there is one (1) athlete in a single bodyweight category, and they lift equal to or more than the respective level MS for that bodyweight category as published in the Appendix 10 (Gold).



## Entries and Registration Process

In order for athlete entries to be accepted, they must meet the following criteria and deadlines:

### Athlete Eligibility

- Be full registered on the IPC Sport Management System (SDMS) with the correct documentation (IPC Eligibility Form and Medical Diagnostic Form) completed fully signed, and uploaded to the athlete profile;
- Have an active license for the 2025 Season;
- Be a minimum of 15 year of age by 31 December 2025;
- Have an international classification status of New, Review, Review + Fixed Date or Confirmed

NOTE: There is no required Minimum Standard (MS) to enter the Cairo 2025 World Championship.

### Entries and Registration Process

All World Championship entries must be completed via the IPC Online entry system at <https://db.ipc-services.org/sdms/app/login> by the entry deadlines displayed below. Visa invitations, accommodation applications, accreditation applications, and travel information must be submitted by no later than the deadlines published below.

### Late entries

Team must contact the WPPO office if there is a late entry request. All respective information provided by the NPC/NF will be reviewed in consultation with the LOC on a 'case by case' basis and the entry may be accepted/rejected accordingly by WPPO.

### Replacements

The WPPO office must be informed if an NPC/NF needs to make a replacement. The replacement of athletes may be accepted due to injury or medical reasons. All respective supporting information regarding the replacement must be sent to the WPPO office and will be reviewed on a 'case by case' bases and accepted/rejected accordingly by WPPO.





## Declaration of Participation

By completing and submitting sport entries, NPCs are considered to have officially declared the participation of their athletes in the specified events/categories.

## Final Entry Process

- All entries by number must be completed by 31 May 2025 and all final entries by name must be completed by 25 July 2025.
- Please note that after this deadline no changes to the final entries and or final team delegation be accepted unless under exceptional circumstances.
- Please note that any decisions concerning this matter will be made by WPPO and are not open for further contest or appeal by any other organization or body.
- Changes of bodyweight category after 25 July 2025 will only be possible during the verification process. No change will be possible after the Technical Meeting.

## Random Weigh-in

According to the WPPO Rules and Regulations Random Weigh – ins of the Athletes may take place in the day of the Event in advance of the warm-up for the specific Bodyweight Category at the discretion of WPPO.

Should an Athlete weight outside of percentage of their specific Bodyweight Category they will be disqualified (DSQ) from the Event.

The percentage is set to 5% of the specific Bodyweight Category, detailed on the table on the right.

After the close of the World Championship the official World Championship results book(s) will be compiled, and it will be posted and uploaded to the World Championship website.

## Rankings

All recognized results in accordance with the above will also be updated on WPPO website in the official WPPO 2025 World and Regional ranking lists. The results of new athletes and athletes meeting the Qualification pathway requirements will be included in the Preliminary Paralympic Ranking List.

## Records

It will be permitted for athletes to break records in accordance with the most current WPPO Technical Rules and Regulations.
