## 1 Dates of Competition

The competition will be a full programme of events for Rifle, Pistol, and VI.

## 2 Venue

The competition will be organized on 2 venues.

(The same venue which was used during Shooting World Cup 2015)

Distance between “Shooting range PAMPAS” and Sport Hall “GRADSKI VRT” is 7 km or 10 minutes driving by bus. The organizers will arrange transportation between the two venues.

SIUS Ascor electronic targets will be used for all events (Qualification and Finals).

- 10m range 50 Targets
- 10m final 10 Targets
- 25m range 30 Targets
- 50m range 50 Targets

Please note that 25/50m Finals will be held at the last bay in the 25m range.

### 3 Preliminary Programme

The preliminary schedule is attached. Please note there may be changes to the timetable once entries close. The final schedule will be sent following the final entries deadline. Finals will be conducted under current WSPS rules in all events (except P5).

### 4 Competition Duration

The competition duration is 5 days plus 2 additional days for International Classification and Equipment Control prior to the start of the competition.

### 5 Rules and Regulations

The Competition will be conducted under ISSF (except for the finals) and WSPS Rules and Regulations. If you require further information, please visit WSPS or ISSF.

WSPS Juries (Jury of Appeal, Competition Juries, RTS Jury, and Equipment Control Jury) will be designated by WSPS to supervise the Osijek 2025 WSPS European Championships. Qualified Range Officers / Referees holding applicable ISSF/WSPS licenses will conduct the competitions.

### 6 Viability of Events

Individual events are considered viable if there are athletes from a minimum of four (4) countries entered through the Entry by Name.

Team events will be considered viable if a minimum of three (3) eligible NPCs have entered teams through the Entry by Name (note: in cases where only 3 teams participate, medals will be awarded according to the minus-one rule.)

Mixed team event will be considered viable if a minimum of four (4) eligible NPCs have entered teams through the Entry by Name.

If an event fails to meet the above minimum viability criteria, it will be not considered viable and will be shot as an MQS event only (except for the mixed team).

## 7 International classification

International Classification will be conducted on 01-02 October 2025 for Physical Impairments (PI) only (R1-R9, P1-P5). A detailed classification schedule will follow after the revision of the final entries by World Shooting Para Sport. At least 4 weeks prior to classification the athlete's completed IPC Medical Information Form and Classification Consent Form must have been uploaded to the athlete's SDMS profile, these forms can be found on the World Shooting Para Sport website: [www.paralympic.org/shooting/teams/downloads](http://www.paralympic.org/shooting/teams/downloads).

Only athletes with an eligible sport class status may compete. Eligible class statuses are Confirmed or Review with a fixed date (2025 or later).

## 8 Results, Rankings & Records

After the competition is finished, results will be reviewed and published on the World Shooting Para Sport website and the Ranking and Records lists will be updated accordingly.

World Shooting Para Sport will maintain world and regional rankings based on the final results list. Only athletes that are licensed, have a sport class status Review (R) or Confirmed (C) and reach the rankings cut-off standard for the relevant event, will have their results recognised for ranking purposes.

## 9 MQS Allocation

MQS scores for the 2026 World Championships can be achieved at this competition. For further details, please refer to the WSPS Competitions page.

## 10 Entries and Registration Process

### 10.1 Athlete Eligibility

All entered athletes must be licensed by the final entries deadline. Athletes' entries not meeting this criteria will be rejected by World Shooting Para Sport.

### 10.2 Authorised Organisation for Entry Registration

All athletes must be entered by their respective NPCs or authorised organisations by the NPC and accepted by World Shooting Para Sport.

## 10.3 Entry Restrictions

### 10.3.1 Maximum number of athlete entries per NPC per event

The Maximum entry per NPC is four (4) 'full' participants per event (athletes eligible to progress to the final, and to obtain records and ranking) if one is a junior in P1-P2, R1-R2 or R7-R8. If no junior athletes are entered, the maximum number of entries is three (3). In mixed events, the maximum number of entries per NPC is four (4) if one is a female or junior. If no female or junior athlete are entered, the maximum number of entries is three (3).

NPCs may additionally enter an unlimited number of 'MQS-only' athletes (athletes are eligible to obtain qualification scores to be recognized for MQS but cannot progress to the event final or obtain records or rankings.) However, in case of insufficient firing points this number may be restricted by WSPS, in a timely manner.

When entering more than 4 athletes to an event via the Online Entry System, the NPC should contact WSPS after making the online entries, confirming which athletes are to be entered as 'full' entry and which as 'MQS-only'.

#### 10.4 Late Entries

Late Entry Requests (submitted after the Final Entry by Name deadline) will only be considered if they are received by WSPS at least One (1) week before the official arrival day.

Such entries may be accepted at the discretion of the LOC and WSPS; however, a Late Entry Fee of 100 EUR will be charged per additional athlete entered. The Late Entry Fees will be invoiced to NPC by the LOC.

#### 10.5 Entry Changes

Replacement Entries may be accepted in the same event only due to injury or medical reason. The NPC must submit a valid medical report to WSPS office for approval. The Organising Committee must also approve if such late changes can be accommodated (e.g., firearms import arrangements). Refer to WSPS Appendix 2 – 5.3.1.

#### 10.6 Accreditation System

To make your accreditation/accommodation for your team, you must submit in SDMS your Final Entry by the final entry deadline (15 August 2025).

## 11 Entry Fee

## Cancellations

In case of cancellation of participation after final entry deadline, the NPC must pay in full the Entry fee based on their Final Entry submitted.

## 12 Accommodation

The official hotels are:

- 1) Hotel Osijek(\*\*\*\*) in Osijek;
- 2) Hotel Matterna(\*\*\*\*) in Čepin;

All participants must be accommodated in official Hotel.

All hotels offer 4\* level services and are friendly for wheelchair users with few fully adapted rooms. Accommodation is offered in double bedrooms, some rooms are twin rooms, the other are double with queen beds.

Due to limited number of twin-bed rooms, the twin rooms will be distributed on first come first serve basis.

The price per night with breakfast for a double room is EUR 190 (EUR 97,5 per person) and for a single room EUR 170.

All bookings with the official hotels must be made through the LOC: according to received Accommodation Forms (in SDMS), the LOC will make booking of the rooms and charge the NPC for accommodation.

## 13 Food Service

### Breakfast

Breakfast is included in the rate for the championship hotels.

- Breakfast starting on 1 October until breakfast on 08 October.

### Lunch

Lunch at the shooting range will only be available for those who order it in advance.

Specific dietary requirements should be made in advance (vegetarian food, European food, etc.) to the LOC by the Meal booking Form. Every effort will be made to cater to your requirements, if sufficient notice is given.

Price for lunch: **EUR 20**

Starters buffet / fish or meat with vegetables or potatoes / Desserts buffet or cheese / Coffee and bread

The meal booking must be paid in advance by bank transfer like entry fees.

### Dinner

Dinner in hotels can be provided in advance with an additional payment of **EUR 25**. The meal booking must be paid in advance by bank transfer like entry fees.

## 14 Transport

Teams are responsible for their own transportation. If you need help to secure local transportation, you may contact the LOC.

## 15 Import of firearms

When entering Croatia, you will need to have an invitation letter and claim possession of the firearms (present an official firearms owners' certificate) to the police officer when crossing the border.

- Persons with an EU firearm permits just have to show the EU firearms permit to the police officer and do not need to show any other forms or pay any taxes.
- Persons arriving from outside the EU or don't have an EU firearm permits, will get an official form from the police when crossing the border, on which they can register up-to three weapons.

Police will issue papers for these firearms, which you must show at departure during check-in and to the police officers.

The tax of **9 EUR** is requested for every submitted form.

**Upon arrival** to Croatia all firearms and ammunition must be transported directly to the Shooting range firearms storage.

**At departure** the firearms and ammunition have to be collected from the firearms storage on the way to airport (not before).

There is no need to send any firearms forms to the OC.

## 16 Visas

NPCs are responsible to obtain a visa if needed. Please contact the organisers for the official invitation letter. You can find information about Visas between Croatia and other countries here:

Please kindly note that all team members (including competitors, technical staff, officials and supporters) attending this event are kindly requested to ensure they have personal, medical and travel insurance as the event will not indemnify individual claims.

The LOC will not cover any illness cases.

## 18 Doping

Doping control will be conducted according to the IPC Anti-Doping Code.

## 19 Medical

Medical and First Aid support will be available at the event.

## 20 Climate

The average temperature in July in Osijek is 26° Celsius, with max. 29°, min 21°.
