HOW THE IPC IS STRUCTURED







THE IPC GOVERNING BOARD

Elected every four years by the IPC General Assembly, the Governing Board is responsible for governance of the organisation. Governing Board members have non-executive roles and are responsible for determining the strategic direction and policies of the IPC, listening to the views of IPC members and stakeholders.

The Board is currently composed of 12 elected members. The President is Brazil's Andrew Parsons, while the Vice President is New Zealand's Duane Kale. The Chairperson and First Vice Chairperson of the IPC Athletes' Council - Malta's Vladyslava Kravchenko and Canada's Josh Dueck respectively - also serve on the Board which meets in-person at least three times a year. Nine of the current Board members are former athletes.

The next IPC Governing Board elections will be held in September 2025.

THE IPC MANAGEMENT TEAM

Led by its Chief Executive Officer (CEO), two-time Paralympian Dr Mike Peters PLY, the Bonn-based Management Team is responsible for managing the IPC's day-to-day activities which aim to fulfil the organisation's strategic objectives.

In his role as CEO, Peters acts as the liaison between the governance and management responsibilities of the organisation.

THE IPC ATHLETES' COUNCIL

The IPC Athletes' Council is the collective voice of Paralympic and Para athletes within the Paralympic Movement. The Athletes' Council serves as an advisory body to the IPC Governing Board, carrying out tasks specifically delegated by the Board.

Six members are elected at the Paralympic Games and three members at the Paralympic Winter Games. In addition, the IPC Athletes' Council can appoint up to five additional members on two-year terms to ensure there is balance between gender, regions, sports and disability groups.

The elected Chairperson is Vladyslava Kravchenko, a Maltese Para swimmer, while the First and Second Vice Chairpersons are Canada's Josh Dueck and Korea's Yoomin Won respectively.

IPC MEMBERS

Formed in September 1989, the IPC boasts 208 member organisations. Membership of the IPC may be granted in the following categories:

183 NATIONAL PARALYMPIC COMMITTEES

A national organisation recognised by the IPC as the sole representative of the Paralympic Movement in the NPC's country or territory.

INTERNATIONAL ORGANISATIONS OF SPORT FOR THE DISABLED

An international organisation recognised by the IPC as the sole worldwide representative of a specific disability group.

17 INTERNATIONAL FEDERATIONS

An international sport federation recognised by the IPC as the sole worldwide representative of a specific Para sport on the Paralympic Games sport programme.

5 REGIONAL ORGANISATIONS

A regional organisation recognised by the IPC as the sole regional representative of IPC Members located within a specific region.

PARALYMPIC DEBUTS

At the Paris 2024 Paralympic Games, three NPCs - Eritrea, Kiribati, and Kosovo - made their Paralympic debut.

Less than 12 months after being granted full IPC membership, NPC Kosovo competed at the Paris 2024 Paralympic Games with one male athlete. "An indescribable feeling" and "a dream come true" is how Grevist Bytyci described competing for Kosovo in the men's 1,500m T46.



With a population of just 116,000, and after a two-day journey to reach the French capital, vision impaired athlete Ongiou Timeon made history as Kiribati's first-ever Paralympian, competing in the men's shot put F11. NPC Kiribati was granted full IPC membership in October 2019.

SUPPORTING MEMBERS TO COMPETE ON THE BIGGEST STAGE OF ALL

Several years of hard work and investment into programmes that benefit IPC members and athletes resulted in the Paris 2024 Paralympic Games attracting more NPCs and female athletes than ever before.

More than 150 athletes from 91 NPCs. plus coaches and technical officials benefited from IPC support to com-Games.

through development programmes All programmes focused on supporting Para athletes on the athlete pathway, equipping leaders to serve Para athletes and developing the next generation of changemakers, while also improving access and participation of persons with disability in sport.

Athletes benefited from several programmes including grants to participate in training camps, attend international competitions and be classified.

Initiatives such as sport technical trainings and training camps benefited coaches and technical officials. A record 168 NPCs, including three new NPCs, as well as the Refugee Paralympic Team, took part at Paris 2024, surpassing the previous record of 164 set at London 2012 and equalled at Tokyo 2020. In total, 84 NPCs won medals, including two NPCs - Mauritius and Nepal who benefited from IPC membership programme support - who medalled for the first time.

Alongside the IPC's development activities, support was also provided to NPCs through the Uniform Support

Programme, a joint solidarity initiative between the International Olympic Committee (IOC), World Federapete at the Paris 2024 Paralympic tion of the Sporting Goods Industry (WFSGI), and sport brands who are WFSGI members. INCREASING INVESTMENT INTO DEVELOPMENT

Sport for Mobility aims to advance the organisational strength and capabilities of all IPC member organisations to better serve Para athletes.

Courtesy of a landmark four-year agreement with the Toyota Mobility Foundation announced in October 2024, the IPC from 2025 onwards will significantly increase its investment into development initiatives that benefit its members.

Toyota Mobility Foundation, whose mission is to create a truly mobile society that will help people around the world live better lives, will provide grant funding to the IPC to deliver a wide range of transformational development initiatives under the umbrella of Sport for Mobility.





BENEFITING ALL IPC MEMBERS, THE PRIMARY AIM OF SPORT FOR MOBILITY IS TO ADVANCE THE WORK AND CAPABILITIES OF IPC MEMBERS IN THREE PRIORITY AREAS:

ATHLETES

Supporting athletes is at the core of the IPC's programming. This area will develop the fundamental building blocks for long-term success including talent identification, competition opportunities, and access to mentors, coaches and classifiers.



LEADERSHIP

The success of athletes relies on the dedication and leadership of changemakers within the Movement. The IPC's programmes support the development of disability inclusion champions equipped to drive positive social change worldwide through sport.



PARTICIPATION

Initiatives in this area focus on working with IPC members to create and improve opportunities for persons with disabilities (including children and youth) to engage in sport, many of them for the first time.

MAJOR ADVANCEMENTS IN CLASSIFICATION

In 2024, a significant milestone has been achieved on the back of a multi-year investment to improve classification.

After more than three years of work which saw over 80 percent of the tunities to engage and contribute, IPC members approved the new 2025 IPC Classification Code in May 2024.

aims to ensure continuous standardisation and harmonisation within the Paralympic Movement. Building on previous editions, the new version provides the highest standards for classification systems, policies, and procedures. This is done in parallel with balancing out the standardisation aspect with flexibility to allow Para sports to cater for their specific needs and capacities, thereby enabling growth and development.

Among some of the changes are revised stages of the classification process, including:

- the verification of an underlying health condition
- eligible impairment assessment
- minimum impairment criteria assessment
- sport class assessment
- updated and strengthened provisions across all aspects of the classification process

In addition, a new International Standard has been produced which IPC's membership, as well as the focuses on regulating the policies athlete community, having oppor- about detecting, investigating, and proceeding with cases of Intentional Misrepresentation.

The 2025 IPC Classification Code The 2025 IPC Classification Code will become effective in January 2025 for all IPC Members, except for International Federations governing sports on the Paralympic Winter Games Sport Programme - the Code is envisaged to become effective for them in July 2026.

CENTRALISING VISION IMPAIRED CLASSIFICATION

The IPC will start to offer International Federations a centralised vision impairment classification service from 2025 onwards following several years of discussions.

Bringing benefits to International Federations, classifiers and, most importantly, athletes, the aim of offering a new central approach is to pool resources to allow greater investment in the development and integrity of vision impairment classification. The result will be standardisation of assessments and a more athlete-centred approach.

CLASSIFICATION MEETING

In October, over 140 experts attended the IPC's Annual Classification Meeting at the IPC's new headquarters to discuss the implementation of the 2025 IPC Classification Code and to exchange best practices.

LAYING THE FOUNDATIONS FOR FUTURE PARALYMPIC GAMES **SUCCESS**

The Paralympic Games take years to plan and organise. In addition to delivering Paris 2024, Team IPC spent the year preparing for all future Games through to 2034.

With preparations gathering apace, the IPC worked closely with the Organising Committee to advance operational planning, including a particular focus on delivering the Opening and Closing Ceremonies given the wide geographic footprint of the Games, consulting with the IPC Athletes' Council on how to maintain the athlete experience around both events.

SALT LAKE CITY-UTAH 2034

Following election in July, the IPC met with officials from the Bid Committee, Governor Spencer Cox and Mayor Erin Mendenhall during the Paris 2024 Paralympic Games. The meeting provided an opportunity for all parties to share their vision for the Games in 10 years' time.

SHARING KNOWLEDGE AND EXPERIENCE WITH FUTURE HOSTS

Delivering the Paralympic Games is one of the most complex projects on earth and takes years to organise.

During 17 intense days, 220 indivaried from behind-the-scenes site visits at competition and non-Weeks prior to Paris 2024, the IPC competition venues, to hybrid classroom-based knowledge workshops.

> All sessions ensured attendees could interact in-person or remotely with representatives of the host OCOG, IPC and other stakeholders. The IPC also provided secondment opportunities for several team members from future Organising Committees.

Once the Paralympic Games had finished, FOAL Finales - debriefs of the main lessons learned from Paris 2024 were held in Milan, Los Angeles and Brisbane. During these sessions Organising Committees assessed their Games experience and the impact on their own planning for the Paralympic Games.

Taking part in the FOAL programme for Paris 2024 were representatives of Milano Cortina 2026, LA28, French Alps 2030, Brisbane 2032 and Salt Lake City 2034, as well as Switzerland 2038, an interested party in hosting the Olympic Winter Games and Paralympic Winter Games.



Paris 2024's success reinforced the importance of a strategic approach to Games planning, and FOAL will help each future OCOG maximise the opportunities that arise from hosting their own edition of the Paralympic Games."

3. DRIVE IMPACT THROUGH PARA SPORT



IPC AND UNESCO CALL FOR A **MORE INCLUSIVE SOCIETY**

On the eve of the Paris 2024 Paralympic Games, the two organisations brought together international decision-makers to draw-up a roadmap to advance the rights and opportunities of the world's 1.3 billion persons with disabilities.

During 'The International Disability Inclusion Conference: Harnessina the transformational impact of Para sport', ministers from 28 countries, Paralympic athletes, Para sport and education specialists, and global experts, advocated for worldwide progress towards disability inclusion through a series of impact talks and 1. IMPROVE ACCESS: panel discussions that showcased expertise and best practice.

The 700 attendees then examined how governments can make innovative policy changes to further inclusive and accessible sport opportunities and explored ways to increase investment in Para sport.

The conference ended with Paralympian Carla Qualtrough, the-then Canadian Minister of Sport and Physical Activity, presenting the UNESCO-IPC Call to Action which made several key policy recommendations, including:

Ensure access and opportunities for persons with disabilities to participate in Para sport and physical activity from grassroots to high performance.





2. INFRASTRUCTURE:

Provide access to safe, inclusive, affordable, accessible, and sustainable sport and recreation infrastructure for all. Promote and ensure access to affordable assistive technology, and accessible information services and media content to support the participation of persons with disabilities in sport.



3. INCLUSIVE EDUCATION:

Increase budgetary allocations to ensure equal access to education, including physical education, and strengthen training of teachers and coaches to support inclusion and fight discrimination.



4. MEDIA INCLUSION:

Encourage policy and decisionmakers as well as editors, reporters. content producers, technical staff and managers in media institutions to integrate the principles of diversity, equality and inclusion in management practices into their employment and working practices.



5. DATA COLLECTION:

m unesco

Support and invest in expanding existing data collection mechanisms for sport, physical education and physical activity to include disabilityspecific data.

REFUGEE PARALYMPIC TEAM **MAKE HISTORY AT PARIS 2024**

Eight athletes and one guide runner competed in six sports at the Paris 2024 Paralympic Games as part of the largest and most successful Refugee Paralympic Team to date.

Representing more than 120 million forcibly displaced people worldwide, the Refugee Paralympic Team arrived in Paris following a week-long training camp in Reims as the best prepared in history.

Led by Chef de Mission Nyasha Mharakurwa, a London 2012 Paralympian, the team excelled and made history by winning its first ever medals.

stunning surroundings of Grand Palais made global headlines when she claimed the team's first medal with bronze in women's Para taekwondo K44-47kg.

Days later, Opening Ceremony flagbearer Guillaume Junior Atangana, running alongside his guide Donard Ndim Nyamjua, produced a personal best to win bronze in the men's 400m T11. During the Games he also set a personal best in the 100m T11.

The Paris 2024 Refugee Paralympic Team was supported by United Nations High Commission for Refugees (UNHCR), Worldwide Paralympic Partner Airbnb, The emotional celebrations of Zakia Khudadadi in the Asics, the French Ministry for Sport and Olympic and Paralympic Games, the Paris 2024 Organising Committee and Centre for Resources, Expertise and Sport Performance of Reims.

They are a symbol of perseverance and hope, and spectators have united in support for the athletes. It's a reminder that people everywhere crave the same things in life: safety and a chance to fulfil their dreams."

As part of efforts to innovate financial resource streams to benefit members, the IPC partnered with TikTok around the Paris 2024 Paralympic Games delivering tremendous results.



Since launching its TikTok channel in February 2020, it has rapidly grown into the IPC's number one engagement platform. By the time of Paris 2024, the channel boasted 4.5 million followers and 175.4 million engagements making it one of world sport's most popular channels.

Due to its popularity and to engage global audiences, TikTok was eager to work with the IPC on a range of content. This included short videos, as well as @Paralympics LIVE content which featured interviews with Paralympians in and around Paris 2024 Paralympic venues, such as the Paralympic Village and Opening and Closing Ceremonies.

Nearly 1.5 million people viewed the @Paralympics LIVE content and a total of USD 500,000 was raised which will now increase opportunities for persons with disabilities to experience the transformational power of sport and physical activity.



A NEW ERA FOR TEAM IPC

The IPC began a new chapter in its short but illustrious history on Monday 22 April 2024 when it moved into its new headquarters.



Following five years of extensive renovations to make it one of the most accessible office spaces in Germany, at the former State Representation building. Located next to the river Rhine and adjacent to the former parliamentary district and the UN Having outgrown its previous home Meeting. Campus, the IPC's new headquarters is approximately 500m from its former home in Bonn.

elevators, accessible bathrooms, and mini kitchens throughout the building on every floor, automatic doors for Team IPC moved into its new home ease of access, and tactile paving - including throughout the garden for those with a vision impairment.

some years ago, leading to IPC departments working across several buildings in Bonn, April's move marked the first time in over a decade Resulting from significant efforts that the whole of Team IPC was able to work under the same roof. IPC EMBRACING STRENGTH IN DIVERSITY

As part of efforts to advance as a diverse and inclusive high-performance organisation, the IPC continues to provide opportunities for women to progress their careers and athletes to pursue opportunities on and off the field of play.

DEVELOPING WOMEN LEADERS

Since 2020, the number of women to hold positions at manager, head, director, and Chief level at the IPC has increased by 19 percent. By the end of 2024, 50 percent at the C-suite level and 66 percent at director level were women.

To develop and nurture this talent, the IPC enrols two team members each year in the Women's Sport Leadership Academy (WSLA). Established in 2014, WSLA provides unique development opportunities for women leaders from around the world to step up, take the lead and make an impact.

In September, Davina Makhan, IPC Membership Engagement Senior Manager, and Michelle Laflamme, World Para Ice Hockey Senior Manager, became the ninth and tenth Team IPC members since 2018 to graduate from WSLA.

TEAM IPC MEMBERS LINE-UP IN PARIS

While much of Team IPC was in Paris to deliver the Paralympic Games, three Team IPC members were there to compete as athletes at the highest level in front of packed crowds and billions of TV viewers.

In Para swimming, Daniela Gimenez, a World Para Swimming Event Co-ordinator, and Alejandra Aybar, an IPC Membership Programmes Co-ordinator, lined up for Argentina and Dominican Republic respectively, while IPC Impact Manager Christian Olsen competed for Denmark in Para athletics.

ENSURING A MORE INCLUSIVE WORKPLACE FOR ALL

The IPC's Disability Employee Resource Group aims to create a more inclusive work environment.

As part of the IPC's move into a new headquarters, the organisation's Disability Employee Resource Group (ERG) played an integral role in the lead-up ensuring the premises lived up to its billing as one of the most accessible offices in Germany.

Over a period of several years, members of the group reviewed construction plans and conducted numerous site visits of the new headquarters, providing feedback to the architect and IPC project manager on what changes should be made to guarantee a barrier-free experience for employees and visitors.

The group also provided advice on the types of furniture and equipment that should be purchased to ensure that all employees with disabilities could thrive in the workplace. Amongst other things, this valuable counsel led to the width of all doorframes being increased to aid mobility for wheelchair users, the purchase and installation of height adjustable desks and the availability of non-spill mugs in all kitchens. Guidance was also given with regards to accessible equipment for the new on-site gym that benefits all Team IPC members.

Established in 2019, the IPC's Disability ERG consists of nine Team IPC members. The group creates a space for employees with disabilities to connect, share experiences, and advocate for their needs. The intended purpose of the group is to create a more accessible and inclusive work environment for all.

Away from April's office move, ahead of the Paris 2024 Paralympic Games, the IPC's Disability ERG supported the organisation of Disability Awareness Training for the entire IPC workforce. The group consulted with theabilitypeople, a British based organisation led by Paralympic swimmer Liz Johnson, who delivered the day-long training sessions.

Grants totalling EUR 4,163 kEUR were awarded and paid to IPC Members in 2023 and 2024 (2023: 2,192 kEUR; 2024: 1,971 kEUR). All grant awards were (1) independently audited by Hartmann & Partner Steuerberatungsgesellschaft mbB and (2) were deemed by the auditors to be awarded in a manner that presented no anomalies or deviations from expected procedures.
